

Sub: Grant of conditional permission to the KLE University, Shri B.M. Kankanawadi Ayurveda Mahavidyalaya Post Graduate Studies and Research Centre, Belgaum, Shahapur, Belagavi, Karnataka with 100 seats in UG (BAMS) course and 63 seats in 10 PG courses namely (i) Dravyaguna Vigyana-05 seats, (ii) Rasa Shastra & Bhaisajya Kalpana-10 seat (instead of 11 seats), (iii) Swasthavritta & Yoga-06 seats, (iv) Agad Tantra avum Vidhi Vaidyaka-06 seats, (v) Kaumarbhritya- Bala Roga-06 seats, (vi) Kayachikitsa-06 seats, (vii) Rasayan & Vajikaran-06 seats, (viii) Shalya Tantra-06 seats and (x) Panchakarma-06 seats under Section 13C/13A of the IMCC Act, 1970 for the academic session 2018-19- reg.

Sir/Madam.

I am directed to refer to the Ministry's order No.R.17011/44/2017-EP (IM-1) dated-07.09.2017 related to admission matter for the year 2017-18 intimating certain shortcomings for rectification for consideration of the case for the academic session 2018-19.

2. The CCIM had carried out an inspection of the institution on 28-29.05.2018 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining the same, it was observed that the Yoga Teacher, Biostatistician, Teacher-student ratio in Rasa Shastra department, Additional ancillary staff, Aadhaar based Geo location enabled attendance system, X-Ray, ECG, USG and Web based

computerized central registration system were not available in the college hospital. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 07.08.2018 to present the case.

- 3. The observation of hearing Committee based on submission made by the college representative during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, PG Ayurveda Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approved Standard Operative Procedures (SOPs) for the UG/PG course(s) for grant of conditional permission for the academic session 2018-19.
- 4. It has therefore, been decided by the Central Government to grant of conditional permission to the KLE University, Shri B.M. Kankanawadi Ayurveda Mahavidyalaya Post Graduate Studies and Research Centre, Belgaum, Shahapur, Belagavi, Karnataka with 100 seats in UG (BAMS) course and 63 seats in 10 PG courses namely (i) Dravyaguna Vigyana-05 seats, (ii) Rasa Shastra & Bhaisajya Kalpana-10 seat (instead of 11 seats), (iii) Swasthavritta & Yoga-06 seats, (iv) Agad Tantra avum Vidhi Vaidyaka-06 seats, (v) Kaumarbhritya- Bala Roga-06 seats, (vi) Kayachikitsa-06 seats, (vii) Rasayan & Vajikaran-06 seats, (viii) Shalya Tantra-06 seats, (ix) Shalakya Tantra-06 seats and (x) Panchakarma-06 seats for the academic session 2018-19 under section 13C/13A of the IMCC Act, 1970, subject to the condition that the college shall fulfil the deficiencies as mentioned below by 31st December, 2018:
 - (i) Aadhaar based Geo location enabled attendance system for teaching staff, nonteaching staff, hospital staff and PG students as per RMS, 2016.
- 5. In addition to above, the following requirements should be fulfilled by the college by 31st December, 2018 to get conditional permission for the next academic session 2019-20:
 - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);

- (iii) all the requirements of the Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016 and
- (iv) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*.
- 6. The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify that the conditions have been fulfilled by means of an inspection and submit a report in this matter to the Ministry of AYUSH for considering the permission matter from the academic session 2019-20.
- 7. This issues with the approval of competent authority.
