2. The CCIM had carried out an inspection of the institution on 17-18.04.2017 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry. On examining the same, it was observed that the higher faculty in Ayurved Samhita department, at least 1P/R+1L in each of 14 departments, teacher-student ratio in Rasa Shastra department and 01 Laboratory Technician in Dravyaguna department and 01 Laboratory Technician & 01 Laboratory Assistant in Rasa Shastra department as per

PG Ayurveda Regulation, 2016 were not available in the college hospital. Therefore, under provisions of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970, an opportunity of hearing was granted to the college on 14.08.2017 to present the case.

- The observation of hearing Committee based on submission made by the college 3. representative during hearing and recommendations & visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS(IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2017-18 vide Ministry's letter No.R.11011/03/2017-EP (IM-1) dated 12.06.2017 (available at Ministry's website <www.ayush.gov.in>) and it has been decided by the Central Government to grant of conditional permission to the KLE University, Shri B.M. Kankanawadi Ayurveda Mahavidyalaya Post Graduate Studies and Research Centre, Belgaum, Shahapur, Belagavi, Karnataka with 100 seats in UG (BAMS) course and 65 seats in 11 PG courses namely (i) Dravyaguna Vigyana-05 seats, (ii) Rasa Shastra & Bhaisajya Kalpana-10 seat (instead of 11 seats), (iii) Swasthavritta & Yoga-06 seats, (iv) Agad Tantra avum Vidhi Vaidyaka-06 seats, (v) Kaumarbhritya- Bala Roga-06 seats, (vi) Kayachikitsa-06 seats, (vii) Rasayan & Vajikaran-06 seats, (viii) Shalya Tantra-06 seats, (ix) Sangyaharan-02 seats, (x) Shalakya Tantra-06 seats and (xi) Panchakarma-06 seats for the academic session 2017-18 under section 13C/13A of the IMCC Act, 1970, subject to the condition that the college shall fulfil the following requirements by 31st December, 2017 which will be verified for granting permission from the academic session 2018-19 onwards:
 - (i) all the Requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
 - (ii) all the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
 - (iii) all the requirements of the Indian Medicine Central Council (Post Graduate Ayurveda Education) Regulations, 2016 and
 - (iv) all the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made thereunder should be fulfilled *in toto*.
