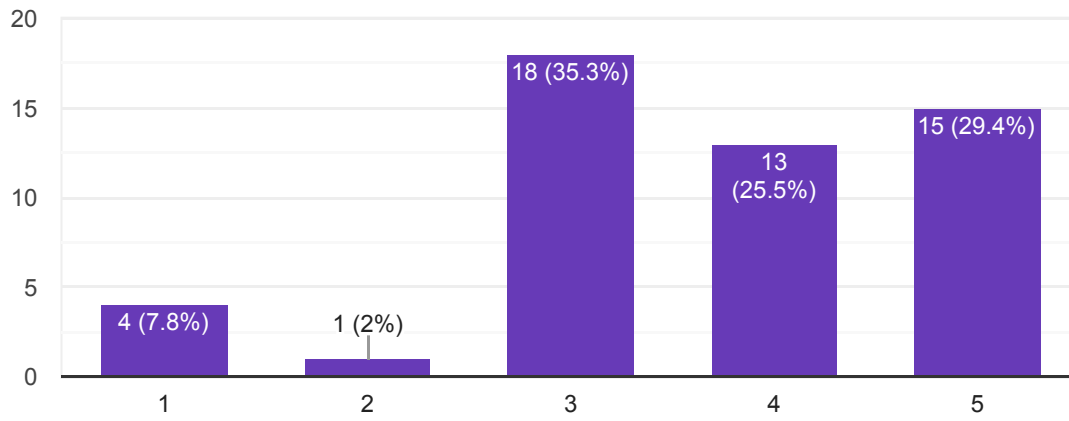

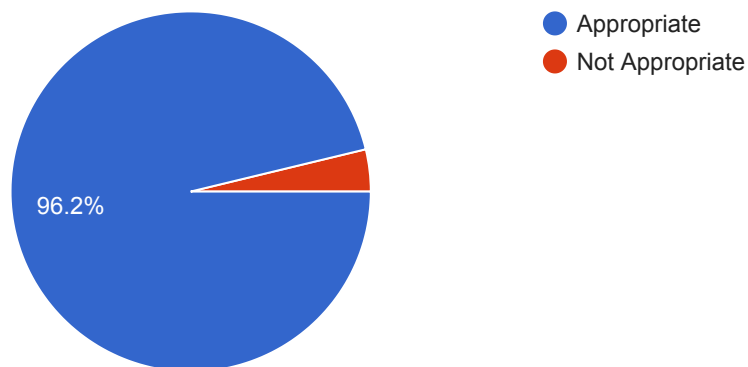

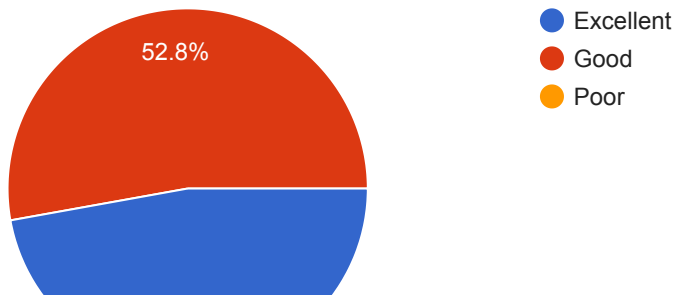
## Seating arrangement in Exam Hall

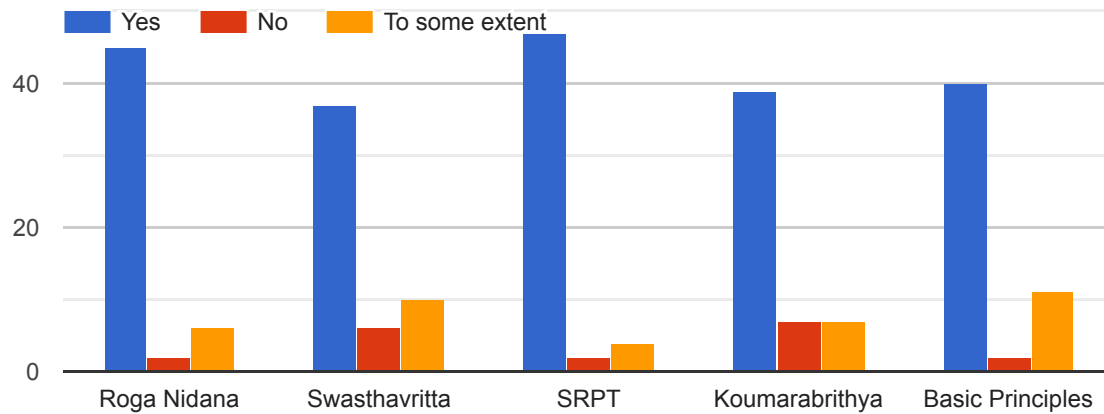

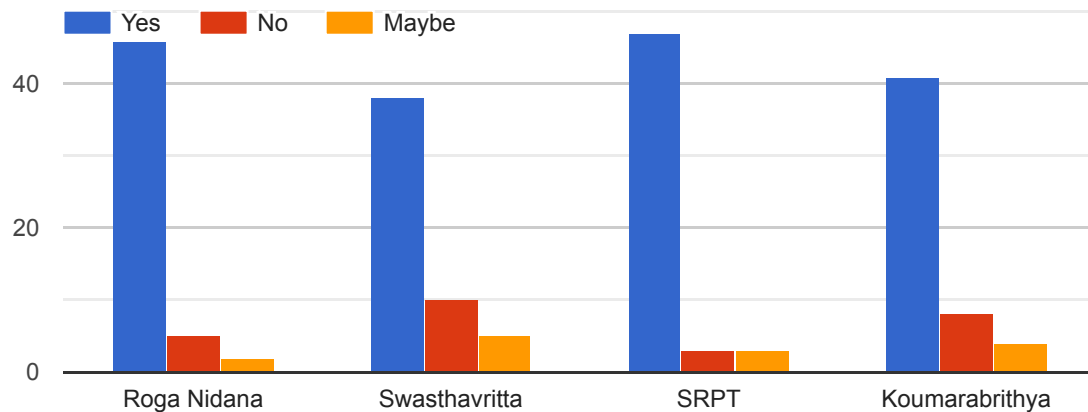

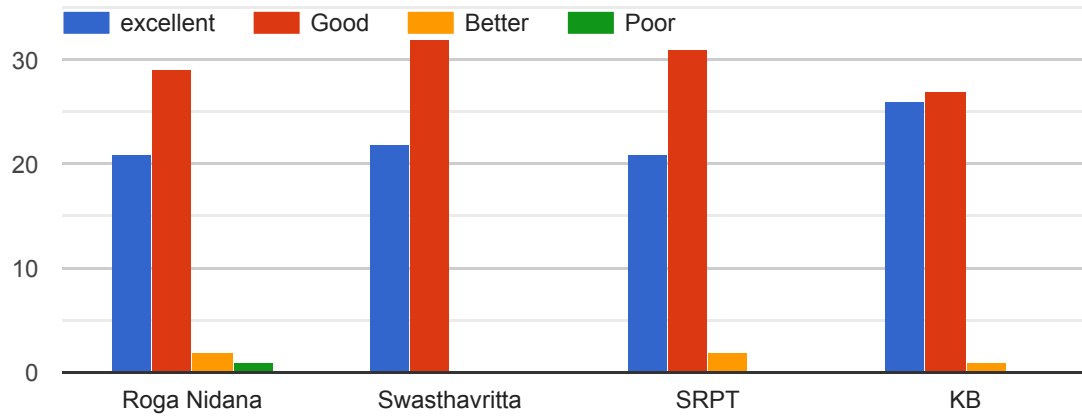

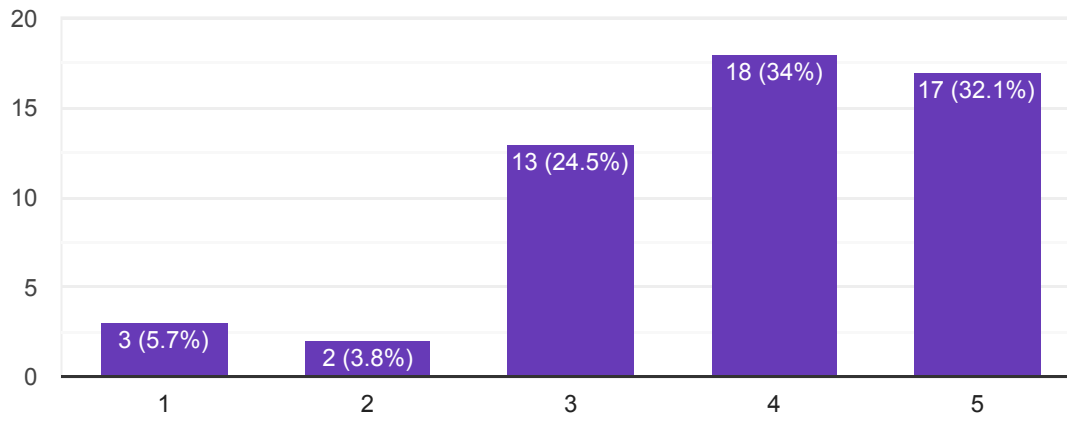
