**Subject:- Inclusion of Qualification in Second Schedule to the Indian Medicine Central Council Act, 1970, Gazette Notification - reg.**

Sir/Madam,

As you are aware that there is a Second Schedule to the Indian Medicine Central Council Act, 1970 in which recognized medical qualification of Ayurved/Siddha/Unani are included. The Government of India amends this Schedule from time to time by including medical qualifications of Indian Systems of Medicine by issuing notification in the Gazette of India.

In this connection, it is to inform you that the Government of India by amending the Second Schedule of IMCC Act 1970 has recognized the Undergraduate/Post Graduate degree of following Universities. The details are as under:-

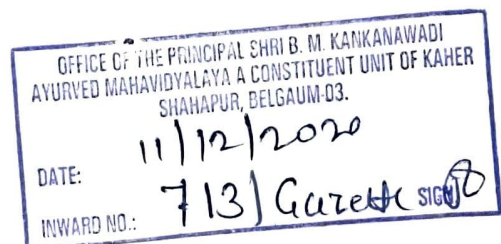

S.O. 3658(E).— In exercise of the powers conferred by sub-section (2) of section 14 of the Indian Medicine Central Council Act, 1970 (48 of 1970), the Central Government, after consulting the Central Council of Indian Medicine, hereby makes the following further amendments in the Second Schedule to the said Act, namely:—

In the Second Schedule to the Indian Medicine Central Council Act, 1970, in Part-I, relating to “Ayurveda and Siddha”, under the heading “Karnataka”,—
